3. Implementation of the current (2014-2017) work plan

The Bureau reviewed progress in the implementation of the current work plan and its four concrete deliverables: best practice guidance on methane emissions (activity A), role of gas in enabling deployment of renewable energy (B), best practice guidance on LNG (C), and the recommendations of removing barriers to use of gas in transport (D).

For activity A, the secretariat noted that the above mentioned Model Framework could serve as the principal building block of the future best practice guidance on methane emissions, which is a deliverable of the 2014-17 work plan (activity A). The case studies presented at the 4th session could be used to illustrate guiding principles and recommendations.

The Bureau noted a lack of progress in implementing activity B (gas and renewable energy).

The secretariat informed that a publication on trends in LNG (activity C) was sent to printers and should be ready by the 4th session. The best practices guidance on LNG, which is another deliverable for activity C, still lack critical elements. Some work was done on small scale LNG. The Bureau concluded that the Group needs to work with IGU and find ways how to accelerate this work. More discussion on this could be held during the 4th session in Geneva.

The secretariat informed the Bureau that Jan Tellkamp, DNV GL is drafting the maritime portion of the recommendations on removing barriers to the use of gas on ships. This document should be ready by the 4th session and will be presented by Jan in Geneva.

4. Participation of the Group of Experts on Gas in the Eighth International Forum on Energy for Sustainable Development (11-14 June 2017, Astana, Kazakhstan)

The Bureau decided that the Group of Experts on Gas should be present in Astana. A 3-hour timeslot will be set aside. The Bureau agreed that methane management as a topic is well covered by the Group and other partners and, as such, should not be addressed in Astana. The Group of Experts on Gas may decide on a different topic for the Forum in Astana. The secretariat will circulate some ideas.

5. Draft work plan 2018-2019

The Bureau noted that the current version of the draft work plan has 8 activities. The Group of Experts should prioritize its activities and choose only those for which "champions" can be found. The draft work plan will be presented as a room document during the 4th session. As such, it needs to be finalized and sent to the Group in time to be reviewed so that an informed discussed could take place on 27 and 28 March.

The next call will take place on 21 March 2017.
