Referring to the item 7 of the Annotated provisional agenda of the 30<sup>th</sup> session of the Implementation Committee under the Espoo Convention (ECE/MP.EIA/IC/2014/1), the Ministry of Natural Resources and Environmental Protection of the Republic of Belarus requests the Committee to consider at the upcoming session the information regarding implementation by the Republic of Belarus of the Committee's recommendations further to the submission by Lithuania (ECE/MP.EIA/IC/2013/2, annex) provided in our letter of 25 November 2013.

With regard to paragraph 11 of the Structure and functions of the Implementation Committee and procedures for review of compliance «the Committee shall make such recommendations as it considers appropriate, **taking into account the circumstances of the matter**», the Ministry requests the Committee to return to consideration of the above mentioned submission taking into account the provided information about implementation of the recommendations finalized at the 27<sup>th</sup> session of the Committee.

The Ministry also requests the Committee to reflect the information about the steps undertaken by Belarus to implement the above mentioned recommendations in its report at the upcoming Meeting of the Parties to the Espoo Convention.
