Through the Convention's work on access to justice governmental officials, judges and other judiciary strengthened the capacity to promote effective access to justice in environmental matters. The Aarhus Convention Parties reaffirmed their commitment to promote effective and inclusive public participation in national, transboundary and international contexts with the focus on international financial institutions for the latter. Further, they reaffirmed their obligation to improve legal frameworks and practical arrangements as to ensure that persons exercising their environmental rights are not penalized, persecuted or harassed in any way for their involvement. A number of valuable examples on these topics were shared by Governments and stakeholders

Through the Convention's work on access to information Governments and stakeholders strengthened their capacities on (a) how to effectively provide information to the public in the event of any imminent threat to human health or the environment; (b) on how to put in place effective legislative and practical measures enabling whistle-blowers and other environmental defenders to report violations in this regard; and (c) on how to effectively produce environmental information harnessing benefits of e-government, open data initiatives and the increased use of modern digital technologies by the public

- At dedicated event taking place at the PreCOP25 in San José, Costa Rica, UNFCCC Parties, other
 interested States and stakeholders were trained by the Aarhus Convention's secretariat on how to handle
 effective and inclusive public participation in climate-related decision-making.
- The Signatories to the Regional Agreement on Access to Information, Public Participation and Justice in Environmental Matters in Latin America and the Caribbean (Escazu Agreement), other interested States and stakeholders benefited from the advisory support of the Aarhus Convention secretariat provided at the Signatories' first meeting.

 Through the Protocol on PRTRs' work countries strenghtened their capacities in establishing effective PRTR systems that meet common international standards and promoted modernisation of reporting by industry

- The Aarhus Convention Compliance Committee assisted 14 Convention's Parties to improve their legislation and practice with regard to access to information, public participation in decision-making and access to justice in environmental matters. This assistance covered a broad range of topics, including environmental impact assessments, nuclear activities, energy plans, spatial planning, waste, water, nature and noise exemption permitting, legal aid, the costs for bringing court challenges in environmental cases and protection of environmental defenders
- The Protocol on PRTRs Compliance Committee worked to assist Parties to further development of the Protocol and improve their legislative frameworks









 Through the work of the Aarhus Convention and the Protocol on PRTRs, countries furthered the environmental dimension of SDG 16 thereby contributing to the achievement of multiple Goals
