

## Rules and procedures prescribed for the issue of TIR Carnets by national associations

#### **Declaration of loss of TIR Carnets**

#### Transmitted by the International Road Transport Union (IRU)

Following an exchange of views about the informal document No. 4 (2005) transmitted by the IRU regarding rules and procedures prescribed for the issue of TIR Carnets by national Associations (TIRExB/REP/2005/25 § 22), the TIRExB expressed the wish to receive additional information about the declaration of loss of TIR Carnets.

The form reproduced in annex is the Loss Declaration Form which has to be filled in by Holders of TIR Carnets when a TIR Carnet has been lost, stolen, destroyed or retained by an official body (ie. Customs, Police). This completed Loss Declaration Form has to be sent to the Association which has issued the concerned TIR Carnet as soon as a used or unused TIR Carnet is known to be missing, in order to allow the Guarantee Chain to proceed with the invalidation of the concerned TIR Carnet.
