Summary of the activities of the network of eTIR focal points


Note by the secretariat

I. Background

1. At its 124th session (February 2010), the Working Party on Customs Questions affecting Transport (WP.30) supported the call of the secretariat to organize activities of the Informal Ad hoc Expert Group on Conceptual and Technical aspects of Computerization of the TIR Procedure (GE.1 or Expert Group) at long distance, by means of a network of focal points for eTIR (ECE/TRANS/WP.30/248, para. 22). At its 125th session, WP.30 stressed the importance for every Contracting Party to nominate a focal point for the eTIR project and to inform the secretariat accordingly (ECE/TRANS/WP.30/250, para. 19). This document presents the status of the network of eTIR focal points and summarizes its activities since the twenty-sixth session of GE.1.

II. Members of the network of eTIR focal points

2. The following thirty-five Contracting Parties to the TIR Convention have nominated at least one eTIR focal point: Albania, Armenia, Austria, Azerbaijan, Belarus, Belgium, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Georgia, Germany, Hungary, Ireland, Latvia, Lebanon, Lithuania, Mongolia, Montenegro, Morocco, Netherlands, Poland, Romania, Russian Federation, Serbia, Slovakia, Spain, Sweden, The former Yugoslav Republic of Macedonia, Turkey, the United Kingdom and Uzbekistan.

III. Information received from the network of eTIR focal points

3. Since the twenty-sixth session of the Expert Group, eTIR focal points have not communicated to the secretariat any issue or input to be brought to the attention of GE.1.

4. Since the twenty-sixth session of the Expert Group, the secretariat requested eTIR focal points for their comments on version 4.2a of the eTIR conceptual, functional and technical documentation (see Annex).
