Record of the Forum on the provisions concerning the safety adviser and their application/implementation in States members of COTIF,

Contracting Parties to ADR and States applying ADN

Paris/Le Creusot, 15-17 June 2004

- 1. At its September 2003 session, the Joint Meeting defined the framework prescribed for the renewal of safety advisers' certificates and in view of the mutual recognition of the certificate within the European Union it seemed appropriate to exchange views on the safety adviser's function and more particularly the examination.
- 2. The Government of France therefore organized a Forum on safety advisers and the application/implementation of provisions in States members of COTIF, Contracting Parties to ADR and States applying ADN. The list of participants can be found in annex 2.

- 3. In order to assess the situation, a questionnaire was drawn up and 21 States replied. The replies served as a basis for discussion. The questionnaire and the replies are reproduced as an addendum to this document. The record of the Forum was prepared following the structure of the questionnaire, and appears as an annex to this document.
- 4. The Government of France invites the Joint Meeting to discuss this record and the conclusions of the Forum.

Annex 1

1. Conditions for sitting the examination

With regard to the conditions of age and/or standard of education required, a broad consensus emerged that there was no need to set them since the standard of the examination itself was such as to ensure qualification irrespective of these criteria.

There was, however, discussion of the obligation of prior training referred to in 1.8.3.8, whether such training has been provided as part of a specific course or organized in the field. It was recalled that the competent authority does not have to require proof of this training. The Joint Meeting has already discussed this issue.

In any case, if the question of training is to be discussed again, it can only be within the Joint Meeting.

2. Organization of the examination

All the participants acknowledged the need to distinguish between the functions of teaching and examining. A body would not be prohibited from taking on the two functions, but their independence must be ensured.

This independence could be the subject of a recommendation.

3. Examination arrangements

This is a problem for the competent authority. Two questions gave rise to discussion: the anonymity of the examination papers and the use of a microcomputer.

Without calling in question the responsibility of the competent authority, it is proposed that 1.8.3.10 should be amended to specify that the competent authority must take all necessary steps to ensure that the examination is impartial, consistent and held successfully.

4. Databank

A distinction should be drawn between the databank of questions used to establish part of the examination topics and the compendium of examination questions and topics intended to be transmitted as part of the exchange of information.

(a) Databank

No provision is made for it in the texts but it exists in a very general sense. A consensus emerged that it should be made official and segmented according to the points listed under 1.8.3.11 and 1.8.3.12 of ADR.

The notion of a single databank accessible to all member States was not adopted because of insurmountable difficulties to date (material, financial, legal and institutional).

(b) Compendium of examination topics

European Directive 2000/18/EC provides that the countries of the European Union are to prepare and submit a compendium of examination questions to the European Commission, and that feedback will be provided. This obligation has not been enforced.

In that the setting-up of a database of questions and its incorporation in the regulations was deemed useful, the possibility was discussed of establishing an exchange of information on the transmission of these databases.

Some States have recommended that examination topics already set should be sent in, since they consider that their database should remain confidential and not be made public. Others, however, have said that they are ready to transmit databases of questions. In certain cases the database has already been published nationally. The UNECE secretariat said that it was prepared to collect this information and consider the possibility of translating it into English, French and Russian, provided that it was submitted in one of these languages, that it had been approved by the Joint Meeting and that the translation of documents of this type was accepted under the rules in force in the United Nations. In view of the reservations expressed by some but also the considerable willingness to establish cooperation, an exchange of information of a voluntary nature could be organized as follows:

- States which so wished should transmit their database of questions to the UNECE secretariat along with case study topics already set;
- In lieu of complete databases, examination topics already set may be sent;
- The information may be placed on the UNECE web site, provided that an adequate level of protection (password) is established;
- The State transmitting the data must ensure that its data are up-to-date;
- The information should be transmitted in the language of the original State which should not have to cover translation costs; the State interested in consulting these data should make this effort.

The various aspects will be formalized by UNECE.

5. Examination standard (harmonization), examination standard (multi-criterion analysis)

After a lengthy discussion, a consensus emerged that a safety adviser should be capable:

- of understanding the regulations;
- of applying the regulations;
- of putting the message across in his undertaking.

The examination should be a means of ensuring this competence. The participants did not, however, arrive at an agreement on the criteria for achieving these objectives.

It was therefore decided to propose to the Joint Meeting that a training and examinations group should be established with responsibility for formalizing these various standards of examination requirements in order to ensure the standard of competence defined above.

The database of questions and the examination topics already set transmitted under the exchange referred to in section 4 would provide core material for the work of the group.

6. Choice of subjects

Purely informative. The decisive role of the experts was noted.

7. Correction of examinations

Purely informative. The participants would like the training and examinations working group that is to be established (see section 5) to address the principle of an eliminatory mark (questionnaire and/or case study and/or the examination as a whole).

8. Issue of the certificate

Purely informative.

Miscellaneous

At the end of the meeting, the participants raised various questions relating to the safety adviser, such as:

- Declaration of safety advisers to the competent authority by undertakings;
- Safety adviser: employee of the undertaking or external consultant?
- Number of sites (or undertakings) under the direct responsibility of a safety adviser.

With regard to this last question, the specification of a quantitative limit was considered to be difficult, although practice in a member State attracted the interest of the participants.

A safety adviser must carry out a regulation audit prior to any contractual commitment with a potential customer undertaking in order to ascertain the level of the workload and time to be given to it within the undertaking.

Conclusion

The Joint Meeting should continue its work by establishing a training and examinations group responsible for more detailed exchanges and the formalization of the examination requirements in order to ensure the level of competence specified by the regulations.
