<u>Proposals to amend document OTIF/RID/RC/2007/30/Add.1 – ECE/TRANS/WP.15/</u> AC.1/2007/30/Add.1

### Joint proposal transmitted by Germany and the Secretariat of OTIF

#### 1. <u>1.3, Note 3:</u>

The reference to the radiation protection programme is not clear. It should read:

"For training with regard to Class 7, see 1.7.2.7.".

#### 2. 1.7.2.7:

This provision was previously contained in 1.3.2.4. However, an amendment that was included in the 2007 edition of RID/ADR/ADN has not been taken into account. Bearing in mind this amendment, the text should read:

"1.7.2.7 Workers [(see 7.5.11, CW33/CV33 Note 3)] shall receive appropriate training concerning the radiation hazards involved and radiation protection including the precautions to be observed in order to ensure restriction of their exposure and that to restrict their occupational exposure and the exposure of other persons who might be affected by their actions."

For reasons of cost, only a limited number of copies of this document have been made. Delegates are asked to bring their own copies of documents to meetings. OTIF only has a small number of copies available.

#### 3. 2.2.7, Note:

This Note should be deleted. Classification must be carried out in accordance with the criteria set out at the beginning of 2.2.7.2.1.1. The packaging is determined on the basis of this classification.

4. Chapter 3.3, special provisions 325 and 326:

In Table A of Chapter 3.2, column 6, for UN Numbers 2916 and 2917, add special provision "325" and for UN Numbers 3328 and 3329, add special provision "326".

Justification: Uranium hexafluoride may also be carried in type B(U) and type B(M) packages.

The same amendment should also be made in the UN Model Regulations.

- 5. Additional amendments in connection with the decision of the ad hoc working group to include the provisions for low dispersible material in RID/ADR/ADN, and alignment of references to the UN Model Regulations
  - 1.6.6.1 (replaces consequential amendment in OTIF/RID/RC/2007/30/Add.1 ECE/TRANS/WP.15/AC.1/2007/30/Add.1) Replace "2.2.7.7" with:

"2.2.7.2.2, 2.2.7.2.4.1, 2.2.7.2.4.4, 2.2.7.2.4.5, 2.2.7.2.4.6, SP 336 of Chapter 3.3 and 4.1.9.3".

- 1.6.6.2.1 and
- **1.6.6.2.2** (replaces consequential amendment in OTIF/RID/RC/2007/30/Add.1 ECE/TRANS/WP.15/AC.1/2007/30/Add.1) Replace "2.2.7.7" with:

"2.2.7.2.2, 2.2.7.2.4.1, 2.2.7.2.4.4, 2.2.7.2.4.5, 2.2.7.2.4.6, SP 337 of Chapter 3.3 and 4.1.9.3".

**4.1.9.1.1** (replaces consequential amendment in OTIF/RID/RC/2007/30/Add.1 – ECE/TRANS/WP.15/AC.1/2007/30/Add.1) Replace "2.2.7.7.1" with:

"2.2.7.2.2, 2.2.7.2.4.1, 2.2.7.2.4.4, 2.2.7.2.4.5, 2.2.7.2.4.6, SP 336 of Chapter 3.3 and 4.1.9.3".

- **4.1.9.2.3** (b) The amended reference ("2.2.7.1.2" instead of "2.2.7.2") in document OTIF/RID/RC/2007/30/Add.1 ECE/TRANS/WP.15/AC.1/ 2007/30/Add.1 is correct. But the new wording "ten times the applicable level specified in 2.7.2.3.2" contained in 4.1.9.2.3 (b) of the UN Model Regulations is incorrect and should be aligned with RID/ADR.
- **6.4.8.14** Amend to read as follows:

"A package containing low dispersible radioactive material shall be so designed that any features added to the low dispersible radioactive material that are not part of it, or any internal components of the packaging shall not adversely affect the performance of the low dispersible radioactive material."

**6.4.12.1** (a) After "or special form radioactive material,", insert:

"or low dispersible radioactive material".

**6.4.12.2** (replaces consequential amendment in OTIF/RID/RC/2007/30/Add.1 – ECE/TRANS/WP.15/AC.1/2007/30/Add.1) Replace "2.2.7.3.3, 2.2.7.3.4, 2.2.7.4.1, 2.2.7.4.2" with:
