#### PREVENTION OF ACCIDENTS

#### Resolution No. 22 adopted by the Sub-Committee on 11 March 1950

THE SUB-COMMITTEE.

HAVING EXAMINED the note by the Secretariat and the memorandum from the Netherlands Government on the prevention of accidents,

DECIDES that an ad hoc Working Party should be set up to study with the assistance of the competent international bodies -

- the prevention of accidents and, inter alia,
- developments in the design of road construction, in the system of road signs and signals and in traffic regulations likely to effect a marked improvement in road safety, and also
- first aid on roads: and

REQUESTS the Executive Secretary to circulate the annexed questionnaire, the replies to which should be in the hands of the Secretariat not later than 1st August, 1950.

# QUESTIONNAIRE CONCERNING PREVENTION OF ROAD ACCIDENTS

  - (b) The main research activities.

## B. Education

- 4. Is road safety training given in schools?

  If the answer is yes -
  - (a) What types of schools?
  - (b) Is it financed by the State, or
  - (c) Is it financed by private enterprise?
- 5. Is a campaign of educational road safety propaganda conducted?

  If the answer is yes, please state -
  - (a) By whom.
  - (b) At what cost annually.
