### I. Introduction

- 1. A report on the work of the informal working group on substances (informal document INF.6) was submitted at the seventeenth session of the Safety Committee, held from 23 to 26 August 2010. The Safety Committee requested that the documents relating to recommended changes be presented at the eighteenth session (see ECE/TRANS/WP.15/AC.2/36, para. 51–56).
- 2. Taking into account the comments made in the meantime, the delegation of Germany submitted informal document INF.2 for the following session of the Safety Committee. At its eighteenth session, held from 24 to 26 January 2011, the Safety Committee requested that a formal proposal to amend Table A should be submitted at the nineteenth session (see ECE/TRANS/WP.15/AC.2/38, para. 13).
