# Collection and dissemination of transport statistics by the United Nations Economic Commission for Europe Questionnaire

#### I. Mandate

1. The Working Party on Transport Statistics (WP.6), at its sixty-first session in June 2010, requested the secretariat to streamline data collection procedures in the field of transport and road traffic safety and to review user needs on a permanent basis (ECE/TRANS/WP.6/159, paragraph 47 (a)).

## II. Proposal

- 2. The Intersecretariat Working Group on Transport Statistics (IWG) proposes to split the short-RAS (short Road Accident Statistics Questionnaire) into two parts: the existing one plus data on alcohol.
- 3. The part of the questionnaire on alcohol is presented below.
