

## Updated provisional agenda for the seventy-second session

### 1. Adoption of the agenda

The Working Party on Lighting and Light-Signalling (GRE) may wish to resume consideration of this subject, awaiting new proposals and sponsors to develop a GTR on possible eligible items.

### 4. 1998 Agreement - Regulations

#### (a) Regulation Nos. 37 (Filament lamps), 99 (Gas discharge light sources) and 128 (Light emitting diodes light sources)

GRE may wish to consider proposals submitted by the expert from the International Automotive Lighting and Light Signalling Expert Group (GTB), introducing new categories of light sources and minor corrections into the above Regulations.

GRE may wish to consider a proposal tabled by the expert from France to delete a design restrictive requirement, taking into account the recent studies by GTB.

GRE agreed to consider a proposal submitted by the expert from Germany on the activation of hazard warning signal in case of excess temperature in certain compartments of M<sub>2</sub> and M<sub>3</sub> buses.

(ii) *Proposal for amendments to the 06 series of amendments*

GRE may wish to recall its earlier discussion on the introduction of flashing side marker lamps for heavy goods vehicles and buses (ECE/TRANS/WP.29/GRE/71, para. 21) and to consider a revised proposal submitted by the expert from Germany (ECE/TRANS/WP.29/GRE/2014/33). GRE is also invited to consider additional transitional provisions proposed by the expert from Germany (GRE-72-05 and GRE-72-06).

(c) **Draft Horizontal Reference Document and collective amendments**

GRE is invited to recall the statement of the expert from the European Commission at the previous session (GRE-72-03). GRE will also be informed about the progress made by the Special Interest Group (SIG) and will revert to the SIG proposal to reactivate the

Horizontal Reference Document Informal Group and to update its Terms of Reference (GRE-71-22).

IWG recommended keeping these documents on the GRE agenda for information purposes, pending a decision with regard to the amendments contained therein.

GRE is invited to consider a revised proposal by the experts from Germany, the Netherlands and the International Electrotechnical Commission (IEC) introducing into Regulations Nos. 48 and 112 requirements to avoid intentional non-approved voltage variation of the passing and driving beam for halogen light sources.

GRE agreed to consider a revised proposal tabled by the expert from Italy, deleting all obsolete references in Regulations Nos. 53 and 74 to avoid confusion and possible incorrect application of the requirements containing those references (ECE/TRANS/WP.29/GRE/2014/38). For Regulation No. 53, GRE may also take into consideration a further proposal by the expert from Germany to delete references to headlamps of Class B of Regulation No. 113 (ECE/TRANS/WP.29/GRE/2014/32).

GRE is invited to consider a revised proposal by the Agricultural Vehicle Lighting Installation informal working group to update and revise Regulation No. 86. For convenience, modifications to the original proposal ECE/TRANS/WP.29/GRE/2014/30 are shown in GRE-72-02.

GRE may wish to consider a revised proposal prepared by the expert from the International Motorcycle Manufacturers Association (IMMA) introducing the possibility of interdependent lamps for dedicated motorcycle lamps into Regulation No. 50.
