

# 3. Facilitating of the coordination of integrated time schedules and tariffs on the Euro-Asian transport links

## 4. Identification of needs and requirements by producers, shippers, traders and freight forwarders in transport and trade on EATL routes

The Group of Experts may wish to recall that based on an adopted work plan (ECE/TRANS/WP.5/GE.2/2013/1) it shall identify transportation needs and requirements

(including obstacles) which face producers, shippers, traders and freight forwarders along nine rail and road EATL corridors.

The Group of Experts may wish to recall that it invited at its twelfth session company Plaske and the Moscow State Institute for Engineers of Transport to update the document initially drafted by Plaske for the twelfth session. The document contains a comparative analysis of time and cost between rail and maritime transport between Europe and Asia (Informal document WP.5/GE.2 (2015) No. 9).

The Group of Experts will consider the presentations by producers, shippers, traders and freight forwarders who share their experiences, best practices, problems and proposals for solutions.
