
Log of comments received by the secretariat on the ITC Strategy

Note by the ITC Bureau and the secretariat

Summary

In implementing relevant decisions of the Inland Transport Committee at its eightieth session (ECE/TRANS/274, para. 17), the Bureau decided at its June 2018 session that two waves of consultations should be conducted with member States and Working Parties/Chairs, one between July-August 2018 and another in October 2018. The ITC Strategy until 2030, as contained in ECE/TRANS/2019/R.1, was cleared by the Bureau, which reached consensus on Draft 3 of the ITC Strategy until 2030 at its session on 29-30 November 2018. Furthermore, the Bureau decided to convene a meeting on 17 December 2018 chaired by the ITC Chair, to inform interested UNECE member States of the result of the consultations that led to Draft 3.
