**WORK OF THE SUB-COMMITTEE OF EXPERTS  
ON THE TRANSPORT OF DANGEROUS GOODS****ST/SG/AC.10/2000/33****Proposal by the drafting group (Chapter 4.1)**

**New title:** General Provisions for the packing of dangerous goods in packagings, including IBCs and large packagings.

Amend the NOTE under the amended title of 4.1.1 to read as follows:

***NOTE:** The general provisions of this section apply to the packing of goods of Class 2, Division 6.2 and Class 7 only as indicated in 4.1.8.2 (Division 6.2), 4.1.9.1.5 (Class 7) and in the applicable packing instructions in section 4.1.4 (P201 and P202 for Class 2 and P621, IBC 620 and LP 621 for Division 6.2).*

**Revised proposal**

1. Add in 4.1.1.3 and 4.1.1.9: "6.3.2" after "6.1.5" in each paragraph.
2. Revise 4.1.8 as follows:
  - "4.1.8.1 Unchanged.
  - 4.1.8.2 The definitions in 1.2.1 and the general ... , except 4.1.1.10 to 4.1.1.12 apply to infectious substances packages. However liquids shall be filled into packagings, including IBCs, which have an appropriate resistance to the internal pressure that may develop under normal conditions of transport.
  - 4.1.8.3 For UN 2814 and UN 2900 an itemized..
  - 4.1.8.4 Unchanged.
  - 4.1.8.5 The provisions of this section do not apply to UN 3373 diagnostic specimens (see P650).

As a consequence of the proposal by the secretariat:

- 1) P201 The 1st sentence should be amended as follows:  
  
"The following packagings are authorized, provided that the general provisions of 4.1.1 and 4.1.3 are met by combination packagings".
  - 2) P202 The 1st sentence should be amended as follows:  
  
"The following packagings are authorized, provided that the general provisions of 4.1.1 and 4.1.3 are met".
  - 3) P621 The 1st sentence should be amended as follows:  
  
"The following packagings are authorized, provided that the general provisions of 4.1.1, 4.1.3 and the special provisions of 4.1.8 are met".
  - 4) IBC620 The 1st sentence should be amended as follows:  
  
"The following packagings are authorized, provided that the general provisions of 4.1.1, 4.1.3 and the special provisions of 4.1.8 are met".
