**A. Preamble**

1. There are many hotels in the world that are primarily for leisure and are not currently included in the electronic exchange of information or electronically booked. This is due to the variety of services they offer which is not currently part of the functionality covered in electronic messages used by the major hotel chains. In Japan alone, there are more than 60,000 hotels of this type. In the past, this type of lodging was mostly used by the local people, but as word has spread of the services they offer, there is more of a demand for these hotels from people outside of Japan. The need to request the general information for these hotels and to book them electronically is growing rapidly. This document covers the first part of this need for the capability to exchange information electronically.

2. In order to distinguish the characteristics of this type of hotel, the name of lodging house is applied in this document. Thus this document pertains to hotels used mainly for leisure that may be located anywhere in the world and need to be supplied to the global markets. The reason for distinguishing between lodging houses and hotels is that the services of lodging houses which are usually offered to customers are greatly diversified compared to hotels.

3. The adjective of the lodging house, small-scale, comes from the fact that lodging houses are usually smaller in room capacity than hotels used primarily by business travellers. It is not intended to limit the scale of lodging houses only to small-scale ones as there are some lodging houses that are larger than traditional hotels. Their requirements are also accounted for in this document.

### C. Objective

5. The objective of this document is to standardise the exchange of specific lodging house information between trading parties. The transactions to request the information from a buying party, like a travel agent or a consumer, and to respond to this from the supplying party or the lodging house are specified and the business information entities required for these transactions are detailed in this document.

6. The business documents are composed of Business Information Entities (BIEs), which when available, are taken from the library of reusable business information entities and when not found, are proposed as new BIEs. The contents of the business documents and the BIEs are presented using class diagrams.

### D. Scope

7. This document (CEFACT/Forum/2006/TBG9) is used in the global travel, tourism and leisure (TT&L) industry and may also be used by any general consumer in the role of a buying party who does not have all the needed information for a specific lodging house. This information is general in nature and any customer whether he is a travel agent or a consumer can have access to this information. There also exists information which is primarily concerned with the products and sales policy and the information provided to a customer may vary depending on whether the requestor is a travel agent or consumer, etc. This latter information will be dealt with in future documents.

8. The class diagram of the lodging house information is developed in a manner that specifies the cross industry reusable business information entities and the TT&L reusable business information entities.

9. The lodging house information process is used to exchange the lodging house information between the supplier and the customer (trading partner or consumer) for the supply of lodging house information ordered, delivered, received, consumed, etc.

10. To simplify understanding, the parties involved are limited to customer and supplier. In the total trade business, each of the parties can have more than one role. For the lodging house information process, the customer can act as the consumer, the buyer, or the travel agent. The supplier covers the roles of the seller, the sales agent or sales company, the lodging house operator and payee.

11. To ensure that the lodging house information process is in line with common practice used between trading parties, the following scenarios are used:

- The lodging house information request by a customer to a supplier
- The lodging house information response from the supplier to the customer

## **E. Business Requirements**

### **(i) Business requirements views**

12. The lodging house information in this document is general information on any specified lodging house and any customer, whether he is a travel agent or a consumer, may access it.

### **(ii) Business process elaboration – Use case diagram cope**

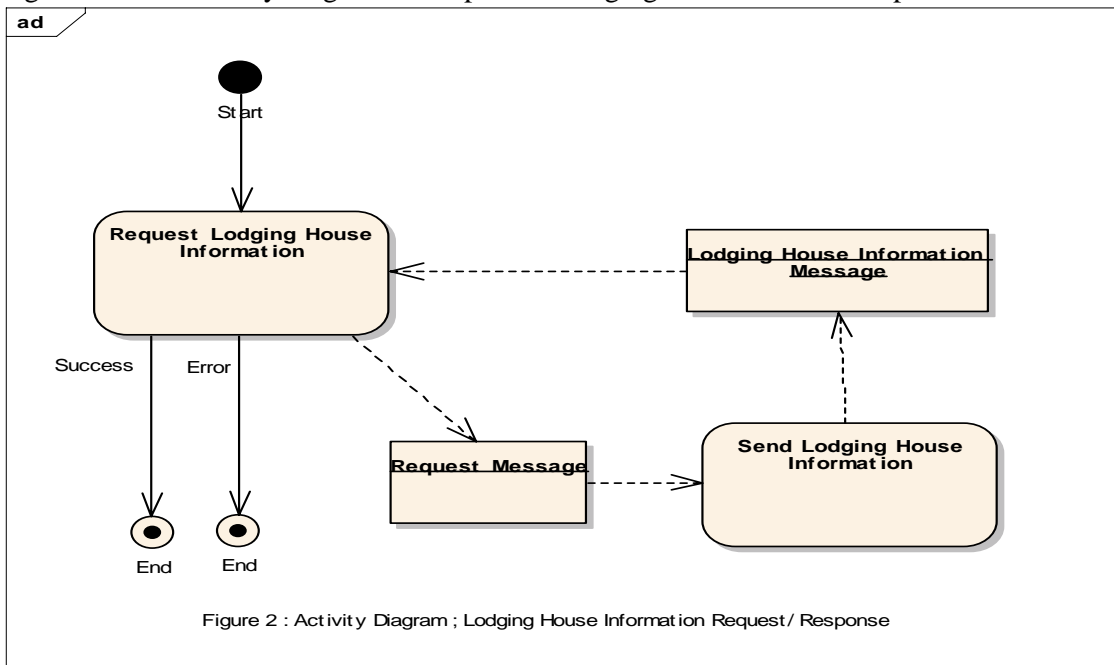
Figure 1. Use case diagram – Lodging house information

13. This process details the request and response of the information for a specific lodging house. Any customer can request the information and get the response containing the information from the supplier if the requesting message is valid in syntax and context. Figure 1 details this concept.

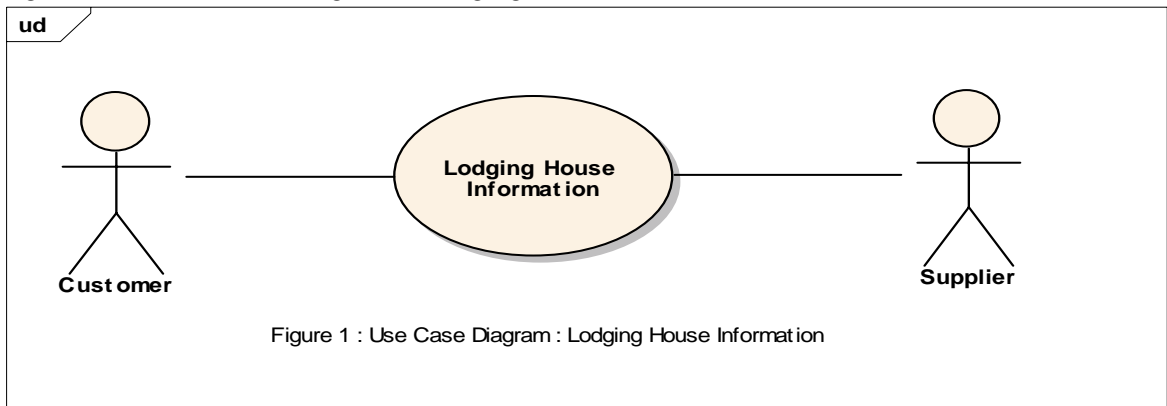
#### **(a) Use case: Lodging House Information Exchange**

15. Any customer can initiate the request for the lodging house information and can get the information once the requesting message is valid in syntax and context.

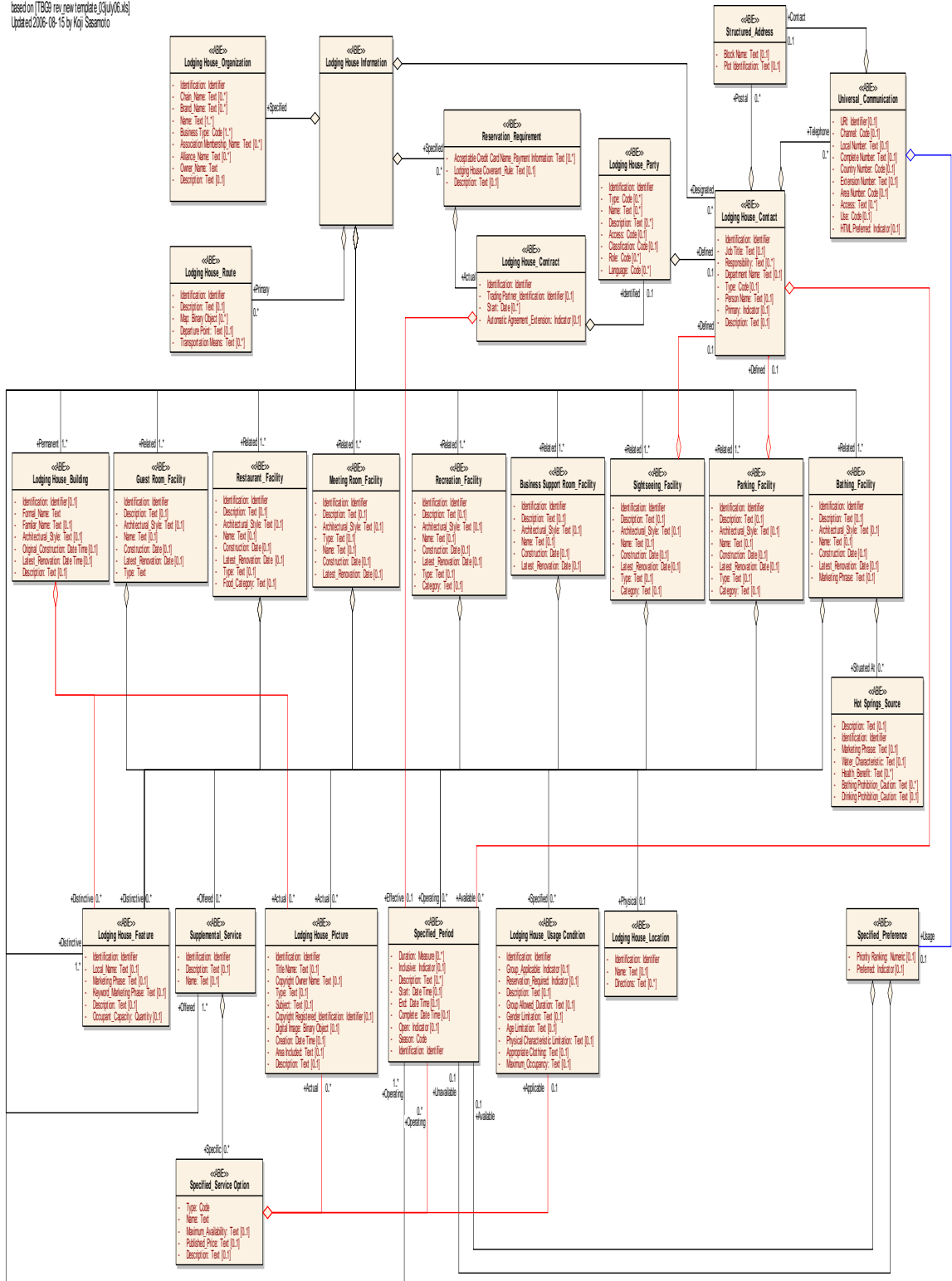


Figure 3 : Class Diagram ; Lodging House Information

**(v) Business rules**

17. There are no special business rules applied to the request and response of the lodging house information. Any customer, whether he is a travel agent or a consumer, can initiate a request and receive the information without any regulation by the business rules.
