# 5. Brief description of good practice

The project aims to enhance women's participation in decision-making, inform elected women on gender equality issues and policies in the new institutional framework for local and regional structures, develop women's knowledge on European and national policies on gender equality, upgrade their communication skills and increase their awareness of gender stereotypes and the reconciliation of professional and private life. The training was delivered through a series of two-day training courses, which were held all over the country in the capital cities of each of the 13 Regions. The training was promoted to local decision-makers (mayors and regional governors) by ceremonies organized to sign the European Charter for Equality of Women and Men in Local Life. The courses ran over two days for groups of up to 30 women, and were divided into five sessions, which cover gender policy, self-empowerment and time management, the gender perspective and gender issues, communication skills and networking.
