## Recommendation No. 21

### ***CODES FOR PASSENGERS, TYPES OF CARGO, PACKAGES AND PACKAGING MATERIALS***

#### ***ANNEX V and ANNEX VI***

#### **I. PREAMBLE**

The United Nations, through its Centre for Trade Facilitation and Electronic Business (UN/CEFACT), supports activities dedicated to improving the ability of business, trade and administrative organizations, from developed, developing and transitional economies, to exchange products and relevant services effectively. Its principal focus is on facilitating national and international transactions, through the simplification and harmonisation of processes, procedures and information flows, and so contribute to the growth of global commerce.<sup>1</sup>

The UN/CEFACT work-program emphasises the need for developing recommendations, which simplify and harmonize the current practices and procedures used in international transactions. Within this context, the role of the UN/CEFACT Information Content Management Group (ICG) is to secure the quality, relevance and availability of code sets and code structures to support the objectives of UN/CEFACT, including managing the maintenance of UN/ECE Recommendations related to codes. The ICG prepared this latest revision of the code list for Recommendation 21.

The attached revision supersedes and replaces the code list released as the seventh revision of Recommendation 21, Annex V and Annex VI, (CEFACT/ICG/2008/IC005) approved by the ICG, in April 2009.

#### **II. CODE LIST PRESENTATION**

1. The code list is presented with the following columns:

##### **Change indicator (CI)**

An indication of the maintenance status of individual entries in the code list.

- a plus sign (+) Added. New unit added in this release of the code list
- a hash sign (#) Changed name. Changes to the unit name in this release of the code list
- a vertical bar (!) Changed characteristic(s). Changes other than to the unit name in this release of the code list, e.g. a change to the numeric code

- a letter X (X) Marked as deleted. Code entries marked as deleted will be retained indefinitely in the code lists. When appropriate, these entries may subsequently be reinstated via the maintenance process
- an equals sign (=) Reinstated. Code entries previously marked as deleted and reinstated in this release of the code list

##### **Code name**

Code value name

##### **Numeric code value**

2 digit numeric code value as represented by the pictorial symbols in Annex IV of Recommendation 21.
